

ORAL QUESTIONNAIRE FOR LICENCED WORKERS

SECTION 1

A. There is one God, Creator of all things, who is infinitely perfect, and existing eternally in three persons: The Father, the Son, and the Holy Spirit.

1. Why should God be defined as "infinitely perfect"?

2. Explain your understanding of "One God" and "existing eternally in three persons: The Father, the Son, and the Holy Spirit".

B. Jesus Christ is true God and true man. He was conceived by the Holy Spirit and born of the virgin Mary. He died upon the cross; the righteous for the unrighteous, as a substitutionary sacrifice, and all who believe in Him are justified on the ground of His shed blood. He arose from the dead according to the scriptures. He is now at the right hand of the Majesty on high as our great High Priest. He will come again to establish his Kingdom of righteousness and peace.

1. What do you understand by "true God and true man" as applied to Jesus?

2. Do you have any difficulty accepting the virgin birth of Jesus? YES/NO What theological meaning does it hold for you?

3. Outline briefly your understanding of "substitutionary sacrifice". (The Doctrine of Atonement)

4. How do you understand the nature of the resurrection of Jesus? What theological meaning does it hold for you?

C. The Holy Spirit is a divine person sent to indwell, guide, teach, and empower the believer for godly living and service, to bring glory to the Lord Jesus Christ, to convict the world of sin, of righteousness, and of judgement.

1. What is meant by referring to the Holy Spirit as "divine person"?

2. What is the role of the Holy Spirit in the Church, and the world, during this present age?





D. The Old and New Testaments, inerrant as originally given whose words were inspired by God, are a complete revelation of His will for the salvation of all people. They constitute the divine and only rule of Christian faith and practice.

- 1. What do you understand the following words to mean in the above statement?
 - a) inerrant
 - b) inspired by God
 - c) only rule
 - d) faith and practice

E. People were originally created in the image and likeness of God; they fell through disobedience, incurring thereby both physical and spiritual death. Subsequently all people are born with a sinful nature, are separated from the life of God, and can be saved only through faith in the atoning work of the Lord Jesus Christ on the cross. The destiny of the unrepentant and unbelieving is everlasting separation from God in conscious torment (Hell); but that of the believer is everlasting joy and blessing in the presence of the Lord (Heaven).

F. Salvation has been provided only through Jesus Christ for all people. Those who repent and believe in Him are justified freely by his grace, are born again of the Holy Spirit, receive the gift of eternal life, and become children of God.

5. How do you distinguish "repent and believe" on the one hand from "born again" on the other?

6. Briefly state what you understand by the term "justified".

G. It is the will of God that each believer should be filled with the Holy Spirit and be sanctified thoroughly, thereby being separated from the power of sin and conformity to the world, and being fully dedicated to the will of God, receiving power for holy living and sacrificial and effective service toward the completion of Christ's commission. This is both a distinct encounter and a progressive experience in the life of the believer subsequent to conversion.

- 3. How may this experience be designated a "distinctive encounter"?
- 4. How might sanctification be designated "progressive"?
- 5. What, in your opinion, are evidences of a sanctified life?
- 6. How will you encourage a Biblically balanced view of Spiritual Gifts and Fruit

H. Provision is made in the redemptive work of the Lord Jesus Christ for the healing of the mortal body. Prayer for the sick and anointing with oil as taught in the Scriptures are privileges for the Church in this present age.

6. Will you teach the message of divine healing for the mortal body and how will you encourage the ministry of prayer for the sick (as mentioned in James 5:13-16) in your local church/ministry?
